The Emergency Food Assistance Program (TEFAP)

TEFAP Eligibility

1. Must be a Michigan resident.
2. At each distribution you will be required to provide your name, self-declare he/she is a current Michigan resident, household size and how you are eligible.
3. Eligibility TEFAP participants must fall at or under 300% of the federal poverty income guidelines. See the chart below.
4. Current participants of SNAP, WIC, CSFP, FPDIR, SSI, students with an approved free/reduced price school meals application automatically qualify for TEFAP.
5. All TEFAP information collection is self-declared. Eligibility must be self-declared at each distribution—either in writing or verbally.
