### The Emergency Food Assistance Program (TEFAP)

#### TEFAP Eligibility

1. At each distribution you will be required to provide your name, self-declare he/she is a current Michigan resident, household size and how you are eligible.
2. Eligibility TEFAP participants must fall at or under 300% of the federal poverty income guidelines. See the chart below.
3. Current participants of SNAP, WIC, CSFP, FPDIR, SSI automatically qualify for TEFAP.
4. All TEFAP information collection is self-declared. Eligibility must be self-declared at each distribution—either in writing or verbally.
