Client Services/Emergency Services now has two water grants. We will open up Walk for Warmth funds commencing December 1st. We are finally at full capacity on our Governing Board. Our office repairs from the water damage have finished up except for the lighting issue in one office. We have retained a lawyer to help us on the issue of paying for the roofing materials that the contractor did not pay. A motion was made to accept the Executive Director's report as presented by John Stapleton and seconded by Marie Whitmire; Motion Carried.
